

**Resolution authorizing the Adult Probation Department of the Franklin County Court of Common Pleas to use the Franklin County Sheriff's Firing Range and Training Academy (Sheriff)**

**WHEREAS**, the Franklin County Sheriff wants to allow the probation officers of the Adult Probation Department of the Franklin County Court of Common Pleas to use the Franklin County Sheriff's Firing Range and the Franklin County Sheriff's Training Academy, which are Franklin County facilities that are located at 6373 Young Road, Grove City, Ohio;

**WHEREAS**, the Board of Commissioners may under section 307.03 of the Ohio Revised Code provide space in a building under its control to a lessee for a public purpose and upon such terms as the Board of Commissioners prescribes;

**WHEREAS**, under the terms of this resolution, it is the intent of the Franklin County Sheriff to allow only probation officers with the Adult Probation Department of the Franklin County Court of Common Pleas to use the facility; and

**WHEREAS**, the Franklin County Sheriff wants to allow probation officers with the Adult Probation Department of the Franklin County Court of Common Pleas to use the Firing Range and/or Training Academy only when (1) the facilities are not being used by the Sheriff's Office, (2) the lessee uses the Training Academy and Firing Range in accordance with the terms and conditions that are included in Exhibit A of this resolution and to any and all of the Sheriff's rules regarding the use of the facilities, and (3) authorized personnel from the Franklin County Sheriff's Office have scheduled the use of the facilities in advance.

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

- 1) Subject to sections two and three of this resolution, the Franklin County Board of Commissioners authorizes the probation officers of the Adult Probation Department of the Franklin County Court of Common Pleas to use the Sheriff's Firing Range and the Training Academy.
- 2) To use the Sheriff's Firing Range and/or Training Academy, probation officers of the Adult Probation Department of the Franklin County Court of Common Pleas must comply with any and all obligations under (1) the terms and conditions that are

included in Exhibit A of this resolution and (2) the Sheriff's rules regarding the use of the Firing Range and/or Training Academy.

- 3) To use the Sheriff's Firing Range and/or Training Academy, the Franklin County Court of Common Pleas must, at the Sheriff's option: (1) pay an administrative fee of \$100 per day that the Adult Probation Department uses either facility and (2) reimburse the Sheriff for hourly wages of a deputy or deputies in accordance with the terms and conditions in Exhibit A.
