

Resolution approving twenty (20) subaward agreements for Youth Afterschool Programs (Department of Job and Family Services) (\$ 2,413,180.52)

WHEREAS, the Franklin County Department of Job and Family Services is authorized to enter into subaward agreements with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to enter into subaward agreements with the Central Community House (2), Clintonville-Beechwold Community Resources Center, Columbus Urban League, Community Development for All People, Directions for Youth and Families, Easter Seals Central and Southeast Ohio, Ethiopian Tewahedo Social Services (2), Godman Guild Association, Eckerd Youth Alternatives, Inc., Ohio Hispanic Coalition, the Salvation Army, St. Stephens Community Services, Vineyard Community Center, Whitehall City Schools (2), the YMCA of Central Ohio (2) and the YWCA Columbus for Youth Afterschool Programs; and

WHEREAS, the Franklin County Department of Job and Family Services proposes to purchase Youth Afterschool Programs from Central Community House, Clintonville-Beechwold Community Resources Center, Columbus Urban League, Community Development for All People, Directions for Youth and Families, Easter Seals Central and Southeast Ohio, Ethiopian Tewahedo Social Services, Godman Guild Association, Eckerd Youth Alternatives, Inc., Ohio Hispanic Coalition, the Salvation Army, St. Stephens Community Services, Vineyard Community Center, Whitehall City Schools, the YMCA of Central Ohio and YWCA Columbus, for the time period of late September 1, 2016 through June 16, 2017, for a total dollar value of \$2,413,180.52; now, therefore,
