

**Resolution approving an amendment to the contract with Arbor E&T LLC dba ResCare Workforce Services for the coordination and management of the Ohio Works First work activity services (an increase of \$4,792,441.86). (Department of Job and Family Services) (\$12,935,862.32)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contract agreements with public and private organizations for the purchase of TANF services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0660-14 authorized the Franklin County Department of Job and Family Services to enter into a contract agreement with Arbor E&T LLC dba ResCare Workforce Services for the coordination and management of Ohio Works First work activity services, for the time period of October 1, 2014 through September 30, 2015, for a total dollar value of \$4,746,687.48; and

**WHEREAS**, Pursuant to the Ohio Revised Code 329.04 and Article III, Sections C and D of the contract agreement currently on file with FCDJFS, the Director of Franklin County Department of Job and Family Services has specific delegation of authority to directly amend contract agreements. Under this authority, the original contract with Arbor E&T LLC dba ResCare Workforce Services was amended by decreasing \$103,267.02 from the original award, for an amended dollar value of \$4,643,420.46, for the time period of October 1, 2014 through September 30, 2015; and

**WHEREAS**, Resolution Number 0721-15 authorized the Franklin County Department of Job and Family Services to amend the contract with Arbor E&T LLC dba ResCare Workforce Services by increasing the contract amount by adding \$3,500,000.00 for an amended total contract value of \$8,143,420.46 and by extending the expiration date from September 30, 2015 to September 30, 2016; and

**WHEREAS**, the parties agree to amend the terms of the contract agreement with Arbor E&T LLC dba ResCare Workforce Services, by adding \$4,792,441.86 to the current amount for an amended total dollar value of \$12,935,862.32 and by extending the expiration date from September 30, 2016 to September 30, 2017; now, therefore,
