

**Resolution approving amendments to four (4) contracts for Title XX Services with HandsOn Central Ohio, House of Hope for Alcoholics, Inc., The Legal Aid Society of Columbus, and Maryhaven Inc. (an increase of \$1,318,100.00). (Department of Job and Family Services) (\$2,095,092.48)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into contracts with public and private organizations for the purchase of Title XX & TANF-Transfer services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Resolution Number 0748-15 authorized the Franklin County Department of Job and Family Services to enter into contracts with HandsOn Central Ohio, House of Hope for Alcoholics, Inc., The Legal Aid Society of Columbus and Maryhaven, for the time period of October 1, 2015 through September 30, 2016, for a total dollar value of \$776,992.48; and

**WHEREAS**, the parties agree to amend the terms of the contracts with HandsOn Central Ohio, House of Hope for Alcoholics, Inc., The Legal Aid Society of Columbus and Maryhaven, by adding \$397,000 to the current contract period; extending the expiration date from September 30, 2016 to September 30, 2017 and adding \$921,000.00 for the new contract period. The total amended value of all the contracts is \$2,095,092.48; now, therefore,

That the attached contracts and purchase orders are hereby approved in the amounts listed.
