

CONTRACT SUMMARY SHEET

Cafeteria and Food Service Supplies

- This Bid provides Cafeteria and Food Service Supplies for Franklin County Correctional Facilities and was competitively bid through the Purchasing Department in accordance with Section 307.86 of the Ohio Revised Code
- In addition to being publicly advertised and posted on the Franklin County Bid Webpage, 19 vendors believed to be able to service this contract received individual notification that the bid was available; 6 were from Franklin County; 12 were from Ohio and 1 was from out of state. Of the notified companies, 13 were Small and Emerging Businesses from Franklin County and Ohio.
- The Contract requires the supply and delivery of Cafeteria and Food Service Supplies for the Franklin County Sheriff's Corrections Centers I and II.
- The bid opening was conducted on March 29, 2013 and three bids were received. The bidders were Gordon Food Service, Inc., Acorn Distributors, Inc., and Interboro Packaging Corporation.
- Franklin County Purchasing Department and the Franklin County Sheriff's Office reviewed the bids to assure compliance with the bid requirements and references. After completion of the evaluations the following contracts are recommended for award:

Gordon Food Service, Inc. (2 items)

Interboro Packaging Corp. (2 items)

Acorn Distributors, Inc. (9 items)

Gordon Food Service, Inc & Acorn Distributors, Inc split award (1 item)

Based on the evaluations of pricing submitted and the items bid the Franklin County Sheriff's Office recommends the award of the items to the lowest and best bidders as detailed on the list attached to this summary.

- The term of the Contract will be for a one year period beginning on the date of approval of the Franklin County Board of Commissioners with the option to extend for 4-additional 1-year periods. .
- A representative of the Franklin County Sheriff's Department will present the resolution to the Board of Commissioners.
