

**Resolution approving COVID-19 Recovery Grants and TANF subaward amendments with the Columbus Urban League and IMPACT Community Action for Workforce Training Programs (an increase of \$3,200,000) (Department of Job and Family Services) (\$4,650,000)**

**WHEREAS**, the Franklin County Department of Job and Family Services is authorized to enter into subaward agreements with public and private organizations for the purchase of TANF, Title XX, CCMEP, General Revenue Fund, and U.S Department of Treasury Coronavirus State and Local Fiscal Recovery Funds authorized in section 9901 of the American Rescue Plan Act of 2021 services pursuant to the Ohio Administrative Code and rules promulgated by the Ohio Department of Job and Family Services; and

**WHEREAS**, Title IX of the American Rescue Plan Act of 2021 (H.R. 1319) authorized the creation of a Coronavirus Local Fiscal Recovery Fund to make payments to units of local government that are necessary expenditures incurred due to the public health emergency with respect to COVID-19; and

**WHEREAS**, Resolution Number 0783-20 authorized Franklin County Department of Job and Family Services to enter into subaward agreements with the Columbus Urban League and IMPACT Community Action for workforce training programs for the time period of October 1, 2020, through September 30, 2021; and

**WHEREAS**, the parties agree to amend the terms of the subaward agreement with Columbus Urban League, by adding \$850,000 in COVID-19 Recovery Grant funds and \$550,000 in TANF funds to the current subaward amount of \$850,000, for an amended total dollar value of \$2,250,000 and extending the expiration date from September 30, 2021 to September 30, 2022; and

**WHEREAS**, the parties agree to amend the terms of the subaward agreement with IMPACT Community Action, by adding \$1,500,000 in COVID-19 Recovery Grant funds and \$300,000 in TANF funds to the current subaward amount of \$600,000, for an amended total dollar value of \$2,400,000 and extending the expiration date from September 30, 2021 to September 30, 2022; now, therefore
