Resolution authorizing receipt of the FY 2021 Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) Planning and Implementation subgrants for the Safe Station 2.0 Project from the Ohio Office of Criminal Justice Services and the authorization of the President of the Board of Commissioners to sign all acceptance documents and waivers related to the Grant Program (OJPP) (\$891,108.88)

WHEREAS, on June 21, 2017, the City of Columbus and Franklin County unveiled the *Franklin County Opiate Action Plan* which has since been updated to the *Columbus and Franklin County Addiction Plan* to address the ongoing overdose crisis; and

WHEREAS, the Franklin County Coroner's Office reported 855 overdose deaths in franklin County between January 1, 2020 and December 31, 2020, a 45.6% increase compared to 2019; and

WHEREAS, the Franklin County Office of Justice Policy and Programs applied for and has received notification of award from the Ohio Office of Criminal Justice Services (OCJS) for a Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) Implementation award in the amount of \$881,124.30 and a Planning award in the amount of \$9,984.58 to evolve the SAFE Station program and launch the SAFE 2.0 Project on the westside of Columbus; and

WHEREAS, the Franklin County Office of Justice Policy and Programs shall serve as the administrative agency for the purposes of program coordination, program implementation and monitoring for the award period of March 1,2021 through September 30, 2023; now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

- 1. Acceptance of the FY 2021 OCJS COSSAP Planning Award in the amount of \$9,984.58 and FY 2021 OCJS COSSAP Implementation Award in the amount of \$881,124.30 are hereby authorized; and
- 2. Be it further resolved, the President of the Board of Commissioners is hereby authorized to sign all acceptance documents and waivers related to the COSSAP grant program.
- 3. That a supplemental appropriation in the amount of \$315,000 is hereby authorized from the unappropriated cash balance as follows
