Resolution authorizing the set aside for the Recorder's Technology Fund for calendar year 2023. (Recorder)

WHEREAS, section 317.321 of the Revised Code authorizes a County Recorder to request that a Board of Commissioners set aside an amount not to exceed \$8.00 from specific transactions in a special fund for the acquisition or maintenance of equipment for the Recorder's Office; and

WHEREAS, the Franklin County Board of Commissioners has previously set aside a portion of the fees to the credit of the Recorder's Technology Fund (Fund 2016), beginning with Resolution No. 1170-93; and

WHEREAS, section 317.321 of the Revised Code was modified through the adoption of Amended Substitute House Bill 59 of the 130th General Assembly so that the \$3.00 fee set aside by Resolution No. 812-11 would remain in effect through December 31, 2018; and

WHEREAS, the Franklin County Recorder previously requested that the set aside be increased from \$3.00 to \$4.00 during 2014, which the Franklin County Board of Commissioners was required to approve through Resolution No. 908-13; and

WHEREAS, the Franklin County Recorder previously requested that the Franklin County Board of Commissioners continue the set aside of \$4.00 for 2019, which was approved by Resolution No. 805-18; and

WHEREAS, section 317.321 of the Revised Code was modified through the adoption of Amended Substitute House Bill 166 of the 133rd General Assembly so that the \$4.00 fee set aside by Resolution No. 805-18 will remain in effect through December 31, 2024; and

WHEREAS, the Franklin County Recorder previously requested that the Franklin County Board of Commissioners continue the set aside of \$4.00 for 2022, which was approved by Resolution No. 871-21; and

WHEREAS, the Franklin County Recorder has requested that the Franklin County Board of Commissioners continue the set aside of \$4.00 for 2023; and

Resolution authorizing the set aside for the Recorder's Technology Fund for calendar year 2023. (Recorder)

WHEREAS, the request from the Franklin County Recorder has been received and entered on the Journal by the Clerk; and

WHEREAS, section 317.321 of the Revised Code was modified through the adoption of Amended Substitute House Bill 166 of the 133rd General Assembly so that the Franklin County Board of Commissioners must approve the set aside of \$4.00 requested for 2023; now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:

- 1. That pursuant to division (E)(3) of section 317.321 of the Revised Code, the set aside to the Recorder's Technology Fund (Fund 2016) of \$4.00 of the fee collected for filing or recording a document for which a fee is charged as required by division (A)(1) of section 317.32, section 1309.525, or section 5310.15 of the Revised Code.
- 2. That the deposit of the \$4.00 set aside into the Recorder's Technology Fund shall continue for one year for the period commencing January 1, 2023 through December 31, 2023.
- 3. That the expenditures from the Recorder's Technology Fund (Fund 2016) shall include equipment purchases, maintenance, and associated expenses for personnel for the Recorder's Office and the Document Imaging Center.
- 4. That the expenditures from the Recorder's Technology Fund (Fund 2016) shall be subject to the appropriation and approval of purchase orders by the Board of Commissioners.
