

Resolution authorizing an Agreement with Kronos SaaShr, Inc. to provide Franklin County agencies, boards, courts, commissions, and Elected Official offices with workforce management systems and related products, services, and solutions.

WHEREAS, Franklin County agencies, boards, courts, commissions, and Elected Official offices have the need to employ workforce management systems in support of their respective operations; and

WHEREAS, workforce management systems include electronic management of payroll, recruiting, performance, hiring, and other Human Resource-related functions; and

WHEREAS, Kronos SaaShr, Inc. offers workforce management systems and related products, services, and solutions under OMNIA Partners Contract #18221; and

WHEREAS, the Ohio Revised Code Section 9.48 Joint purchasing programs authorizes the County as a political subdivision to "(p)articipate in a joint purchasing program operated by or through a national or state association of political subdivisions in which the purchasing political subdivision is eligible for membership"; and

WHEREAS, this Agreement with Kronos SaaShr, Inc. will serve as a countywide master agreement from which any Franklin County agency, board, court, commission, or Elected Official office may execute one or more Order Forms to procure workforce management systems and related products, services, and solutions to support their respective operations; and

WHEREAS, the term of OMNIA Contract #18221 is in effect through March 17, 2024 and the term of each order shall be as set forth in its respective Order Form; and

WHEREAS, Purchasing recommends that the Agreement with Kronos SaaShr, Inc. be approved and that signature authority be delegated to the County Administrator; now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, FRANKLIN COUNTY, OHIO:
